The opening of the congress coincides with the beginning of the Ramadan. Federal President Christian Wulff, who has been a patron of the German Congress on Crime Prevention for several times, has put his speech for the 20th anniversary of the German Unity under the headline „Appreciate diversity – Support solidarity“ in which he i.a. mentioned that „first of all we need to take a clear position. An understanding of Germany, that affiliation is not restricted to a passport, a family history or a creed, but covers a wider field. Christianity belongs to Germany without a doubt. Judaism belongs to Germany without a doubt. That is our Christian-Jewish history. But also Islam now belongs to Germany. Johann Wolfgang von Goethe expressed in West-

östlicher Divan („West-Eastern Divan“) over 200 years ago: „He who knows himself and others, here will also see, that the East and West, like brothers, parted ne’er shall be.“ In this sense, I am glad to wish all people with Muslim faith to the beginning of the Islamic fasting month a blessed Ramadan.

The German Congress on Crime Prevention (GCOCP) on the one hand is the in 1995 founded and meanwhile biggest annual congress worldwide on the topic area crime prevention and adjoining fields of prevention. On the other hand, the GCOCP forms with its institute for applied prevention research (DPTi)<sup>2</sup> as well as further key activities a platform for information, knowledge transfer and interdisciplinary dialogue between prevention practice, prevention research and prevention politics. My special thanks in this place go to our national and international partner organisations and their representatives as well as the whole team of the GCOCP in the background.

In total, over 500 speakers and institutions inform about the current (inter-)national status of crime prevention work.

In addition to the exchange of the whole range of topics of crime prevention as well as adjoining fields of prevention, the congress dedicates itself to this year’s key topic. „Prevention and freedom – For the necessity of an ethical discourse“ – with this theoretical sounding title, very urgent current and practice-oriented questions are picked up. Prevention moves in the area of tension between security and freedom. Both are moral value categories and supporting pillars of the democratically composed society. How far can the wish for security go, if, at the same time, the freedom of individual or certain groups is being unsettled by preventive arrangements? Is prevention a value in itself or shall the decisions for or against prevention arrangements be led by rational cost-benefit-calculations? Prof. Dr. Regina Ammicht Quinn from the International Centre for Ethics in the Sciences and Humanities at the University of Tübingen will give us a broad overview on the key topic of the congress in her congress report and her opening speech which will be complemented by numerous lectures on both congress days.

Within the congress, the 10th Annual International Forum (AIF) will take place with high-ranking international speakers. Besides that, I am glad that a great many of interesting stage plays and movies will be shown. Numerous parallel events complete the programme. ### **Prevention and integration**

Local, governmental and civil society structures are currently faced with a very special challenges in Europe and the current social situation demands clever preventive

action in many ways and better preventive concepts and strategies. The German Congress on Crime Prevention takes the situation thematically up and highlights within this year's congress also the intersection of (crime-)prevention with the range of topics of integration, social cohesion, radicalisation and strengthening of democracy.<sup>3</sup>

Prevention and integration are closely connected in many ways. Prevention and integrative acting are particularly successful when on the one hand they react early to concrete situations and on the other hand are oriented long-termed and sustainable. What kind of supporting contributions can be fulfilled by projects, programmes and strategies from the wide field of crime prevention for the integration of refugees in municipalities? Nationwide, a variety of projects and initiatives in municipalities exist. They support reducing prejudice and creating a social coexistence. Nevertheless, preventive initiatives for supporting the integration of asylum seekers are not established in the municipalities comprehensively. At this point starts the idea of the newly arranged expert and information portal [www.pufii.de](http://www.pufii.de). It is the aim of the web portal to bundle efficient projects and make them available for other municipalities, to provide information and the exchange between experts and therefore to make a contribution of prevention for the work of integration in the municipalities. I wish all participants and guests a stimulating information and experience exchange and as many impulses and cooperation agreements as possible for further concerted work between prevention practice, prevention politics and prevention research.
